LEGAL ADVOCACY COMMITTEE (LAC) HIGHLIGHTS

EJAZ CHOUDRHY MOTION

This spring, the CMLA-ACAM intervened in the Ontario Superior Court of Justice motion of *Ejaz Choudry (Estate). v. Peel Regional Police Services Board, et al.* This case involved the shooting death of Mr. Ejaz Choudry (an elderly, innocent Muslim man of South Asian descent) by Peel Regional Police officers during a routine wellness check. The deceased's estate has filed a lawsuit against the police. The police have, in turn, filed an interim motion to seek a publication ban of any information that could identify the officers involved in the death.

The Ontario Superior Court of Justice issued its decision to deny the officers' request for the publication ban. In its decision, the Court specifically adopted the CMLA-ACAM's submission that "insofar as the policing of society and particularly the policing of racialized communities is concerned, making an order exempting a court proceeding from the open court principle would be super-extraordinary."

Thank you to **Zain Naqi** (and his associate, **Annecy Pang**) for leading this advocacy exercise, as well as our internal review team for their assistance in crafting our position.

CSIS ACT SUBMISSIONS

This spring, the LAC led an exercise to file submissions related to the proposed amendments to the *Canadian Security Intelligence Service Act* (the "Act"), which were primarily based on foreign interference. The CMLA-ACAM's response noted that the Act proposed to expand CSIS' scope without adequately acknowledging or rectifying past injustices. Additionally, the amendments appear to propose a heightened level of surveillance, raising questions about the commitment to protect civil liberties – an issue that has continuously had a disproportionate effect on the Muslim community in Canada.

In its submissions, CMLA-ACAM noted additional concerns including:

- Serious privacy concerns and past instances of surveillance;
- Concerns regarding the compulsion of information production;
- Lack of accountability measures, such as annual reporting and regular reviews to ensure transparency and oversight;
- Lack of clarity on terms such as "foreign individuals" and specific examples of targeted information; and
- Potential exploitation of Canadian datasets considering past injustices suffered by Muslims due to CSIS' actions.

Thank you to all members, from across the country, who provided valuable input on our submissions.

LEGAL ADVOCACY COMMITTEE (LAC) HIGHLIGHTS

BILL C-20

On October 21, 2024 the CMLA-ACAM was invited to the Standing Senate Committee on National Security, Defence and Veterans Affairs to provide expert testimony on Bill C-20: An Act Establishing the Public Complaints and Review Commission ("PCRC") and amending certain Acts and statutory instruments. Bill C-20 received Royal Assent on October 31st.

CMLA-ACAM member, Pantea Jafari represented the CMLA-ACAM at the Senate hearing.



The newly created PCRC will investigate complaints and carry out reviews regarding both the RCMP and the Canada Border Services Agency ("CBSA"), and will bring some long-needed changes to how complaints regarding the RCMP are handled. This includes allowing for third-party complaints, the explicit ability for the PCRC to carry out specified activity reviews, and ensuring that the PCRC reflects the diversity of Canadian society.

However, significant outstanding problems with the legislation that the government failed to rectify during the Parliamentary study of the bill will need to be addressed as the new Commission is put in place. This includes ensuring that much-needed third-party complaints are not excluded on baseless grounds, that complaints regarding patterns of abuse are investigated, and that, as much as possible, the Commission itself investigates complaints, rather than the RCMP or CBSA themselves.

The new law unfortunately also leaves significant gaps in the complaint and review process. In particular, it fails to provide for the possibility for a stay of removal or other redress in the course of or following a complaint, and it denies the ability for a party to seek judicial review of the Commission's decisions.

The CMLA-ACAM was one of nine civil society groups who raised concerns with Bill C-20, and whose advocacy efforts resulted in significant improvements to the legislation, including:

- Allowing third parties, including civil liberty, human rights, refugee and migrant rights, and other civil society organizations, to file complaints with the new Commission and request that the Commission undertake reviews;
- Extending the deadline for submitting complaints to two years; and
- Removing unnecessary barriers around which complaints the Commission may pursue.

CMLA NATIONAL LEGAL CONFERENCE




The CMLA-ACAM hosted its annual National Legal Conference, a 2-day hybrid event, on October 24th and 25th.

ATLANTIC CHAPTER UPDATE









The CMLA-ACAM Atlantic Chapter continues to collaborate with other entities to amplify Muslim voices across the profession and facilitate meaningful opportunities for its members. Here is a snapshot of what we have been up to lately:

On May 28, 2024, the CMLA Atlantic Chapter, in collaboration with CBA-NS Branch, Federation of Asian Canadian Lawyers – Atlantic Canada Chapter, and Canadian Association of Black Lawyers – Nova Scotia, hosted a **"Path to the Bench" diversity panel** which featured powerful stories of resilience from Chief Judge Perry F. Borden, Associate Chief Justice Lester Jesudason, Justice Gail Gatchalian, and Justice Aleta Cromwell. The panel was moderated by Hanaa Al Sharief, Chair of the CMLA-ACAM Atlantic Chapter and Chair of the Equity Committee, CBA-NS.

On May 3, 2024, on behalf of the Atlantic Chapter, Chair Hanaa Al Sharief attended the joint CMLA-ACAM and MLSA Spring Gala in Toronto.

On March 6, 2024, Farhan Raouf, the Atlantic Chapter's LAC representative, was a panelist on **"How to Navigate a Difficult Conversation",** organized by the Schulich School of Law EDI Committee.

On November 2, 2024, Hanaa Al Sharief, was a panelist on **"Breaking Barriers: Diversity in Business Law"** organized by Business Law Association of Dalhousie Schulich School of Law, in collaboration with Dalhousie Black Law Students Association (DBLSA), Dalhousie Asian Law Student Association (DALSA), and Dalhousie Indigenous Law Students Association (DILSA) where students were invited to meet BIPOC lawyers and learn from their experiences.

BRITISH COLUMBIA CHAPTER UPDATE

The CMLA BC regularly hosts a number of in-person events for its members to build community. CMLA BC also hosted a **Palestine Healing Circle** on March 6, 2024. The event featured a fireside chat sharing perspectives of lawyers from the Jewish and Palestinian communities. The event also included facilitated discussion, story sharing, and mental health support guided by clinical counsellors from Ruh Care. Another well attended event was our iftaar event on March 27, 2024 at Baghven Uyghur Cuisine which supported Palestine through Islamic Relief Canada.

Representatives from the CMLA BC met with the Honourable Attorney General of BC, Niki Sharma, on April 29, 2024, at the BC legislature to discuss critical issues impacting Muslim legal professionals and the broader Muslim community in British Columbia. This meeting was a pivotal step in our ongoing efforts to combat Islamophobia and anti-Palestinian racism in British Columbia. CMLA BC articulated the urgent need for action in several key areas, including cultural competence training for elected officials, enhanced legal protections against Islamophobia and anti-Palestinian racism, and diversity initiatives in public sector institutions. The introduction of the Anti-Racism Act was also discussed.

ONTARIO CHAPTER UPDATE



CMLA Ontario has had a busy year providing legal and social support to law students and legal professionals across the province. The Ontario Chapter worked closely with the Muslim Legal Support Centre to connect lawyers, students, and the broader community with legal counsel to address issues surrounding the right to protest, freedom of expression in the workplace and schools, and assisted with issues around student encampments.



CMLA Ontario was proud to host numerous events and supports for law students including:

- "Prepping for In-Firm Interviews": A panel discussion that included crown counsel, litigation associates, the human rights tribunal, and a Bay Street litigation partner;
- "Beyond OCI's: Forging Your Path": A session on forging a career path outside of the structured OCI process;

- Mentorship matches for law students, articling students, and junior associates; and

CRISIS IN PALESTINE: CMLA-ACAM LOCAL EFFORTS

Education and Community Outreach

CMLA-ACAM chapters across the country have hosted **"Know Your Rights"** sessions related to protests and student encampments, including healing circles in BC specific to the legal community.

Advocacy

CMLA-ACAM issued a formal request to implore Hon. Ted Arnott (Speaker of the Legislative Assembly of Ontario) to reverse his recent decision to ban the Keffiyeh, a traditional Arab headdress, at the Ontario Legislature.

Gaza Family Reunification

CMLA-ACAM has been working with the Muslim Legal Support Centre (MLSC), National Council of Canadian Muslims (NCCM), and the Gaza Family Reunification Project to help Palestinian-Canadians bring their extended family members from Palestine to Canada. Supporting our Students

CMLA-ACAM has been working closely with Muslim Law Student Associations across the country at this dire time.

CMLA-ACAM issued a Statement on Police Brutality in Alberta Against Student Protestors and is working to support students participating in peaceful encampments and protests.

CMLA-ACAM MEMBER SPOTLIGHT

Nader Hasan, Toronto, ON

Nader Hasan is a partner at Stockwoods Barristers and practises criminal, regulatory and constitutional law at the trial and appellate levels. He defends clients accused of white-collar crime (fraud, money laundering, foreign corruption), violent offences (homicide, terrorism, sexual assault), drug offences, and professional misconduct. Nader also has an expertise in digital privacy law and search and seizure law. Nader has appeared in more than 20 cases at the Supreme Court of Canada, including as lead counsel to the successful appellants in *Clyde River v. Petroleum Geo-Services Inc., 2017 SCC 40*, a landmark Indigenous rights decision.



Nader's recent work includes successfully representing UMAR ZAMEER at the Ontario Superior Court of Justice.

Nader Hasan was one of the two lawyers who represented Umar Zameer. Mr. Zameer had been charged with first degree murder following the death of Toronto police officer Detective-Constable Jeffrey Northrup. After three years culminating in a 6-week trial, Mr. Zameer was acquitted.

On July 1, 2021, Umar Zameer, his wife Aaida, and their 2-year-old son were enjoying an evening sightseeing around Nathan Phillips Square. As the night grew late, they returned to their car in the underground parking lot to drive home. While getting into their car, a man and a woman in plainclothes approached them aggressively, demanding they stop the car. At that moment, a large grey van pulled up in front of the Zameer family car, blocking their exit. In an attempt to escape, Mr. Zameer reversed and then drove forward, accidentally hitting the man, who later succumbed to his injuries.

Mr. Zameer later discovered that the man was a plainclothes police officer investigating an unrelated incident. He was oblivious that he had hit anyone. When he learned that he had in fact struck the officer, Mr. Zameer and his wife explained that they had no idea the man and woman were police and that they had believed that the man and the woman were trying to rob them. Still, the police charged Mr. Zameer with first degree murder and the Crown Attorney pursued those charges all the way through verdict.

Mr. Zameer's case underscores the importance of the right to a fair trial and the need to ensure that cases are judged by their facts, not sensational newspaper headlines.

The Muslim legal community followed this case closely given its potential repercussions on the broader Muslim community. The CMLA-ACAM congratulates Nader Hasan and his team on their efforts.

Jouman El-Asmar Edmonton, AB

Jouman El-Asmar is an experienced attorney and a member in good standing of both the Barreau du Québec and the Law Society of Alberta. She is the founder and principal attorney of EL-ASMAR LEGAL, a thriving boutique law firm specializing in Canadian Immigration and Refugee Law. Jouman has built a strong reputation for her dedication to achieving successful outcomes for her clients.

Over the course of her career, Jouman has appeared numerous times before the Immigration and Refugee Board and the Federal Court of Canada, consistently delivering favorable results for her clients. Her deep knowledge of the law, combined with her strong advocacy skills, has earned her a track record of success in even the most complex cases.



Jouman's approach to law is rooted in her trauma-informed practice, ensuring that clients not only receive expert legal representation but also feel safe, heard, and supported throughout the legal process. She is a member of the Canadian Muslim Lawyers Association (CMLA), where she co-founded the Alberta chapter in 2020, and the Canadian Association for Refugee Lawyers (CARL), where she was elected by her peers to sit on the national executive board in 2021. She has also served on the Board of Directors for the 'Association Québécoise des Avocats et Avocates en droit de l'Immigration' (AQAADI) from 2019 to 2021, working to improve the practice of immigration law in Quebec.

In addition, Jouman is also a member of Lawyers without Borders, and the 'Association des Juristes d'Expression Française de l'Alberta (AJEFA), a legal association that promotes public access to legal services in French and the use of French language in the administration of justice in Alberta. She is regularly called upon to present conferences and webinars on various topics related to refugee and immigration law.



LEGAL ADVOCACY

A longtime advocate of social justice and migrant rights, Jouman works closely with members of marginalized communities and racialized minorities. Since 2022, she has been co-chairing the Family Separation Working Group of the Canadian Association of Refugee Lawyers, a litigation and advocacy group challenging unacceptable processing delays for reuniting minor children with their refugee parents.

As the co-founder of the Alberta chapter of the Canadian Muslim Lawyers Association, Jouman has been recognized as a voice of leadership in the Muslim community. She has been invited as a delegate to advocate on behalf of issues affecting Muslim communities' rights in Alberta with various government stakeholders and organizations, including the Alberta legislature.

In December 2023, Journan joined the 'International Center of Justice for Palestinians' – ICJP Canada – as a staff member. ICJP is an independent organization of lawyers, academics and politicians who work to promote and protect the rights of Palestinians globally.

On November 5, 2024, along with a coalition of legal advocates, ICJP launched a lawsuit against the Canadian government at the Ontario Superior Court against for Canada's failure to act to prevent genocide in violation of its legal obligations under the Genocide Convention (1948), and of the rights of Palestinian-Canadians under the Canadian Charter of Rights and Freedoms.


CMLA-ACAM MEMBER ACHIEVEMENTS
